All monies are NON-REFUNDABLE Deposit of \$500.00 is required to hold a puppy. A SECOND NON-REFUNDABLE PAYMENT OF \$500 is required at 6 weeks of age. Full balance to be paid at 8 weeks **no exceptions.**

The kennel name of "Battle Born" will precede the registered name you choose for this puppy (e.g. **Your Dog's Name** Battle Born) on AKC registration papers. This allows us to keep track of our puppies.

All puppies that are being cropped will be done by a professional vet with experience in the breed. Procedures will be done at 8 weeks of age. Upon receipt by the Buyer(s) the breeder is **NOT** responsible for posting issues of any kind.

Buyer(s) agrees to maintain appropriate preventable health care of puppy including, but not limited to, inoculations, parasite preventatives and will immediately seek medical attention for any condition or injury the dog may experience.

Buyer(s) states that he/she is not acting as, or as any part, an agent in the purchase of this puppy and that the buyer(s) will not sell, trade, barter, exchange, or in any way give or transfer this puppy, or any of its progeny to any agent or pet store. Violation of this clause entitles the seller to liquidated damages in an amount of \$5,000.

Should buyers find themselves in a situation where they can no longer keep or want the animal for any reasons **it will be returned to the breeder and the purchase price WILL NOT BE REFUNDED**. The seller will allow the buyer to rehome the animal but must contact the breeder first. The breeder will make the final decision where the animal will be rehomed.

The buyer(s) agrees to keep the seller informed of any treatment as it occurs. This provides the seller an opportunity to follow up on puppy and give us important feedback and information on the health of ours dogs for future generations.

Buyer agrees the puppy **WILL NOT** be left alone in a backyard or kennel and **WILL NOT** be chained or "tied out". This puppy is sold with the understanding it is going to a select and loving home, will receive proper nutrition, a warm housing in cold weather, cool housing in hot weather, and be a member of your family. The puppy will be properly socialized and trained.

As with any, and all, living things there unfortunately can be no guarantees of a future without problems. The seller does **NOT** guarantee against any diseases or injuries that can be acquired after the puppy/dog has left the sellers home/possession.

Buyers agrees to have puppy examined by a licensed vet of their choosing within 3 business days of receiving possession of puppy. Proof of the examination must be provided to seller within the 3 business days via email to seller at [battleborndobermans@gmail.com](mailto:battleborndobermans@gmail.com). Please retain proof of this vet visit. Buyer may return puppy to seller for a full refund with 3 business days, should the vet certify through diagnostic evaluation and evidence that puppy is suffering from a debilitating illness. Seller reserves the right to have the puppy evaluated to confirm the seller's veterinarian's diagnosis.

If the puppy is sold on an AKC Limited registration, it is understood that the puppy is sold as a pet and will not be used for breeding purposes. Purchaser agrees to have the puppy spayed or neutered prior to its 24-month birthday. Buyer agrees to register the microchip within 7 days of getting puppy. The buyer understands and acceptance of these conditions.

Sires and Dam receive annual health exams; have been tested for **VWD** and **DCM**. No one can guarantee genetics, but the breeder guarantees that should die underage of 1 yr. from a genetically caused health issues, the breeder will give you a replacement puppy of equal value on the next available litter of 4 or more pups. And no instance will the breeder provide a refund in lieu of replacement puppy.

Proof of sudden death due to a genetic illness must be provided to the breeder for my vet to reviewed and concurrence that the death was due to a genetic cause, for a replacement puppy. Breeder will be available for the life of this Doberman to answer any questions and provide any help.

This Agreement constitutes the entirety of the obligations, rights, and duties of all parties to this contract. No other terms, verbal or written, apply.

If part of this Agreement is deemed void as a matter of law, the remaining parts shall remain valid and fully enforceable.

This contract is governed by the laws of the state of Nevada. The parties agree that any dispute regarding the subject matter and/or terms of the contract shall be heard in Clark County, Nevada, and no legal action of any kind regarding the terms and conditions of this Contract shall be instituted in any other jurisdiction other than in Clark County, Nevada. Further, the parties to this contract agree that if legal action of any kind is taken, no party will be responsible for the other party's attorneys' fees or costs in an amount in excess of \$1,500.

Buyer has read this contract, understands fully the contents thereof. Failure of the buyer to live up to this agreement will entitle the seller to reclaim the Doberman and its registration papers which will be transferred back to the seller.
